This Addendum forms a part of the contract documents and modifies the original bidding documents dated November 2024 and all previous addenda, if any. Acknowledge receipt of this addendum in the space provided in the bid forms. Failure to do so may subject the bidder to disqualification.

## **QUESTIONS AND CLARIFICATION**

- Q: There is no bid item for topsoil and I do not see where it is called for. Is that correct? A: Topsoil is included in the pay item for seeding and mulching.
- Q: Should bid item 17 be 452 for the 9" concrete drives instead of 305? A: The pay item should be 452 instead of 305. The 452 spec will need to be followed
- Q: Should there be a bid item for the excavation and embankment required for the sidewalk? A: Excavation and embankment is included in bid price for the concrete sidewalk

Q: Is bid item 11 supposed to be 204 Subgrade Stabilization with Geogrid as shown on plan sheets 19 and 20? What is the thickness of the gravel and type of geogrid? There are no descriptions for the numbered items.

A: The gravel is 12" thick, ODOT type B and uses biaxial geogrid.

- Q: Can Grueninger Way be closed to thru traffic ?A: As per the MOT notes, traffic can be reduced to a 1-lane with appropriate traffic barrels, canes, and flaggers.
- Q: On Springfield Pike can the curb lane be closed during the day while we are working?A: Contractors are to create MOT plan if anything differs from the MOT notes, it is up to them if they need to close the lane to complete the proposed work.

Q: On Grueninger Way there is no bid item to replace the catch basin tops as called for on the plans. Also, are new castings and precast concrete tops both required?

A: Bid item was added. The catch basins are to be replaced in accordance to ODOT 611.10C

Q: Plan sh. 20 calls for an ODOT Type 4 depressed curb at the drive aprons but there is no bid item for this.

A: As per the pay item note for driveway aprons, the type 4 curb is included in the bid price for the aprons. The detail is provided to indicate how the depressed curb should be constructed.
