SPECIFIC PROJECT REQUIREMENTS

1 - CONTACT DURING BIDDING

2 - DRUG-FREE WORKPLACE PROGRAM

- 2.1 In accordance with Ohio Revised Code §153.03 and during the life of this project, the Contractor and all its Subcontractors that provide labor on the Project site must be enrolled in and remain in good standing in the Ohio Bureau of Worker's Compensation ("OBWC") Drug-Free Workplace Program ("DFWP") or a comparable program approved by the OBWC.

3 - OHIO ETHICS LAW

- 3.1 Contractor agrees that it is currently in compliance and will continue to adhere to the requirements of Ohio Ethics law as provided by Section 102.03 and 102.04 of the Ohio Revised Code.

4 - PERIODIC PAYMENTS

- 4.1 This project is expected to be funded in whole or in part by the Ohio EPA **WPCLF/WSRLA** Program. The Contractor shall comply with all requirements of this program. The periodic payments to the Contractor may be made in whole or in part through the OWDA. In paragraph 14.02 C.1. of the General Conditions, change "ten days" to "sixty days."
- 4.2 Ohio EPA must approve all change orders prior to a change order item being paid on a pay estimate.
- 4.3 This project is expected to be funded in whole or in part by the OPWC. The Contractor shall comply with all requirements of this program. The periodic payments to the Contractor may be made in whole or in part through OPWC. In paragraph 14.02 C.1 of the General Conditions change "ten days" to "sixty days."

5 - CORRECTION PERIOD

- 5.1 The Correction Period in Section 13.07 of the General Conditions shall be changed from a one (1) year to a two (2) year period.

6 - INSURANCE

- 6.1 Section SC-5.04(D) of the Supplementary Conditions shall be deleted and no "all risk builders risk" or "installation floater" insurance need be purchased by the Contractor.

- 6.2 See the following Bid Set Sections for Insurance Requirements:
- A. Section 1, Instructions to Bidders, Part 10 Insurance
 - B. Section 3, General Conditions, Article 5 Bonds and Insurance (EJCDC) or Article 11 Insurance and Bonds (AIA), whichever is used in the Bid Set
 - C. Section 4, Supplemental Conditions

7 - WORKING HOURS

- 7.1 No work shall be performed between the hours of 7:30 PM and 7:30 AM nor on Saturday, Sunday, or legal Holidays, without written permission of the Owner.

8 - SUBCONTRACTING LIMIT

- 8.1 The successful Bidder shall not subcontract work totaling more than 50% of the total contract.

9 - PROJECT COMPLETION

- 9.1 All work including restoration and clean-up shall be completed no later than the contract completion date. Failure to complete all work within the allotted time will result in assessment of liquidated damages. Upon completion of all work and written notification of same by the Contractor, the Engineer and Owner will compile a punch list. The punch list will be sent to the Contractor. All punch list work shall be completed to the satisfaction of the Engineer and the Owner within 14 days after receipt of the punch list. Failure to complete the punch list work within the allotted time will result in assessment of liquidated damages.

10 - SITE & BUILDING ACCESS
