The Contractor hereby agrees to commence work under this Contract within ten days from date and to substantially complete the work by **NOVEMBER 15, 2019** or be subject to liquidated damages of \$250.00 per calendar day.

The Owner agrees to pay the Contractor in current funds for the performance of the Contract, subject to additions and deductions, and to make payments on account thereof, as provided in the General Conditions.
